Weatherford, Texas is a strong community of 38,000 citizens located approximately 30 miles west of Fort Worth and approximately 60 miles west of Dallas. This safe, family-focused city with a high quality of life and a healthy economy is quickly becoming one of the premier places to live in the North Texas area. The City's small-town feel and convenient access to big city amenities make it one of the most livable communities in the area.

Weatherford was founded in 1858 and values its historic traditions while strategically planning for its future. For outdoor enthusiasts, Weatherford offers a mountain bike trail, disc golf, an all-inclusive park for kids, a lake, access to over 19 parks, and a hike and bike trail system that is over five miles long. Amazing outdoor concerts and popular annual events, including its unsurpassed Fourth of July celebration and parades, provide entertainment for all ages.

Weatherford has a commitment and pride in its strong community philosophy and recognizes the importance of working with citizens and local partners such as the college, businesses, and realtors and homeowners' associations on economic development projects. With an Extra Territorial Jurisdiction (ETJ) of 180 square miles, the City is expanding in many areas and is expected to reach a population of 160,000 by 2070.

The downtown area is currently experiencing various renovations and provides additional entertainment opportunities for the community. Visitors to Weatherford enjoy the City's many unique treasures, including a historic shopping district full of antique, boutique, and specialty stores, as well as quality restaurants. The old-time Farmers' Market, First Monday Trade Days, and a bounty of Victorian-era homes draw visitors from throughout the region to the City.

GOVERNANCE & ORGANIZATION

Weatherford operates under the council-manager form of government. The City Council consists of four members and a Mayor. The Mayor and Council Members are elected at-large by place and serve staggered three-year terms.

City administration is responsible for coordinating and overseeing the efficiency of all departments, under the direction of the City Council, and for implementing the policies, procedures, and programs established by the Council.





FINANCE OVERVIEW

The Finance Department serves as the fiscal steward of the City of Weatherford, managing comprehensive financial operations including accounting, budgeting, payroll, purchasing, and utility financial services. Through strategic financial leadership, policy development, and regulatory compliance, the department ensures sound financial management that supports the City's growth and community values.

The department is comprised of dedicated professionals working collaboratively to maintain fiscal responsibility, transparency, and accountability. Finance fosters innovation between departments, residents, and stakeholders to ensure financial decisions align with community needs and strategic priorities.

The City of Weatherford's Director of Finance should be a strategic financial leader with extensive governmental accounting experience, exceptional analytical capabilities, and the vision to modernize finance operations while maintaining fiscal integrity.

Strong knowledge of GASB standards, GFOA best practices, and modern financial management technologies.

Knowledge of debt management, investment policies, utility financial operations, and Texas municipal finance laws.

Proven success managing audit processes, federal grant compliance, internal controls, and fraud prevention measures in a governmental environment.

ESSENTIAL DUTIES

Provides strategic leadership and direction for comprehensive finance operations; develops, monitors, and revises financial policies and procedures; formulates cash and debt management programs.

Supervises finance staff including Budget Manager, Senior Accountant, Payroll/HR Specialist, Purchasing Coordinator, and Accounts Payable Coordinator; provides oversight of utility billing operations including Utility Services Manager and billing staff through the Budget Manager; provides mentoring and professional development.

Serves as primary financial advisor to Assistant City Manager/CFO, City Manager, and department heads; prepares comprehensive financial analysis and strategic recommendations.

Oversees annual budget development through Budget Manager; reviews revenue projections and expenditure estimates; presents financial recommendations to City Council.



Coordinates annual independent audit including Single Audit compliance; prepares Annual Comprehensive Financial Report (ACFR); maintains relationships with external auditors.

Implements robust internal control systems and fraud prevention measures; ensures compliance with federal, state, and local financial regulations.

Directs payroll operations, purchasing processes, and accounts payable functions; ensures accuracy, compliance, and efficiency in all financial operations.

Oversees Tyler Munis ERP system administration and optimization; ensures data integrity, user training, and system security coordination with IT department.

Manages utility rate analysis, revenue projections, and regulatory compliance; coordinates with utility operations through Budget Manager.

Serves as primary liaison with auditors, bond rating agencies, financial institutions, and other governmental entities; represents City's financial interests professionally.
