GOVERNANCE & ORGANIZATION

The City of Dumas operates under the Council-Manager form of government, with a Mayor and five City Commissioners elected at large to serve staggered two-year terms. The Mayor presides over meetings and works closely with the City Manager, who is appointed by the Commission and serves as the City's chief executive officer, responsible for daily operations and the implementation of Council policy.

City operations are organized through a focused set of departments that deliver essential services to residents and businesses. These include the City Manager's Office, Finance and Utility Billing, Police, Fire, Building Permits and Inspections, Solid Waste and Sanitation, Streets and Public Works, Water, Wastewater, Gas Utilities, Animal Control, Code Enforcement, and Emergency Management. Together, these departments reflect Dumas' commitment to efficiency, safety, and long-term community investment.

Economic GROWTH



- The Dumas Economic Development Corporation (EDC) is actively developing a 265-acre industrial business park with infrastructure already in place (including underground utilities) to attract manufacturing, logistics, food-processing and renewable-energy firms.
- The city/EDC broke ground in 2022 on a significant infrastructure project in the business park: water, sewer and drainage enhancements.
- A \$1 million federal grant from the Economic Development Administration (EDA), matched by local funds, was awarded for road, water and sewer infrastructure to support business growth in the park, with job creation (105 jobs) and private investment (\$3 million) targets.
- Transportation and pedestrian infrastructure is also advancing: A project by the Texas Department of Transportation (TxDOT) in the Amarillo district will include pedestrian infrastructure in Dumas, with a let date of March 2025.
- The city is investing in water-security infrastructure given region-wide pressures: The depletion of the Ogallala Aquifer is driving Dumas to build above-ground water storage and reinforce redundancy in its water supply system.
- The city council is pursuing a strategic planning grant through the DRIVE program for an economic development strategic plan (2025) focused on quality of life, workforce, and growth.

The POSITION

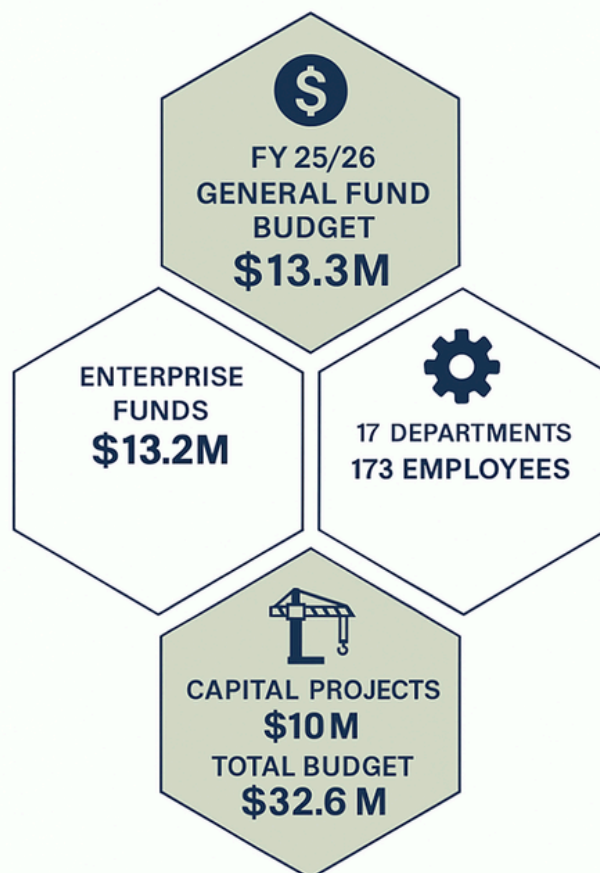
Under the direction of the City Manager, the Finance Director serves as a key member of Dumas’s leadership team, responsible for safeguarding the City’s fiscal health and ensuring its continued growth and stability. This position oversees all financial operations, including accounting, budgeting, payroll processing, cash management, and financial reporting. The Finance Director plays an essential role in guiding city leadership through informed, transparent decision-making that supports Dumas’s commitment to responsible governance and long-term community investment.

The City of Dumas manages a balanced operating and capital budget that supports a wide range of municipal services, from public safety and public works to parks, and community development. As the City continues to invest in infrastructure and economic development, the Finance Director will help steer those initiatives by providing expert financial analysis, policy recommendations, and multi-year planning guidance.

This is a hands-on leadership role in a city that values collaboration and innovation. The Finance Director directly manages the Finance Department staff and works closely with the City Manager, City Commission, and department heads to ensure the effective use of City resources. The successful candidate will bring strong technical expertise, sound judgment, and a commitment to excellence in public service.

Minimum Qualifications

Bachelor's degree in Accounting, Finance, Business, or Public Administration and five (5) years of progressively responsible experience in governmental or public-sector finance management; or an equivalent combination of education, training, and experience demonstrating strong financial and administrative capabilities.

Preferred Qualifications

- Municipal fund accounting experience is highly preferred.
- Certified Public Accountant (CPA) or Certified Government Finance Officer (CGFO) designation strongly preferred.
- Demonstrated experience in comprehensive financial management, including budget development, forecasting, auditing, and internal controls.
- Experience supervising staff and managing multiple funds, including enterprise or utility operations.

Preferred Knowledge

- Knowledge of Governmental Accounting Standards (GASB) and familiarity with Government Finance Officers Association (GFOA) reporting standards.
- Knowledge of Texas Truth-in-Taxation laws for annual property tax calculations and tax rate adoption.
- Understanding of Generally Accepted Accounting Principles (GAAP) and public-sector auditing standards.
- Proficiency in financial management software and spreadsheet applications.
- Familiarity with legal, ethical, and professional standards for municipal finance operations.
- Principles of efficient resource management, capital improvement planning, and long-term financial forecasting.
- Practices of public-sector administrative management, team leadership, and cross-departmental collaboration.

Preferred Standards

- Integrity and sound judgment in all financial and organizational matters.
- Strategic thinking and the ability to connect fiscal policy with citywide goals.
- Strong organizational and communication skills, with the ability to explain complex financial concepts to diverse audiences.
- Approachability and active community involvement, reflecting Dumas's collaborative culture.

COMPENSATION & BENEFITS

The City of Dumas is offering a competitive salary range of \$90,000 to \$110,000, commensurate with the candidate's experience and qualifications.

In addition to base compensation, the City provides a comprehensive benefits package designed to support the well-being and long-term stability of its employees. Full-time employees receive medical, dental, life insurance coverage, and a variety of leave benefits, including paid holidays, vacation, and sick leave.

Dumas participates in the Texas Municipal Retirement System (TMRS), offering one of the most reliable public-sector retirement programs in Texas, with a 6% employee deposit rate and a 2:1 employer match. Employees become vested after five years of service and are eligible for full retirement after 20 years. TMRS also includes a 70% repeating cost-of-living adjustment (COLA) and 100% updated service credit.
